Mayor Ruebke called the Monday, April 21, 2025, council meeting to order at 5:30 p.m.

## City Attorney - each item limited to 15 minutes

Reported to the council that the question of human remains being interned on private property has come up and should be discussed and what the City's stance on that issue will be so the ordinance can be written accordingly.

#### Public Comments - limited to 5 minutes

Nate Hiatt addressed the council with his idea for purchasing land and creating a housing addition close to the K14 exchange. The ground would need to be annexed into the city limits and he would require assistance getting utilities to the area. The ground is up for auction so if the sale goes through, he will be back with a proposal.

#### 1. 2024 Audit Report

Christina Henson with the Loyd Group provided the 2024 audit report and ending year financial documents. The Recreation Commission received points for areas of concern that were not corrected from the 2023 audit. The city did not receive any points for their portion of the audit.
